The Challenge

As a company that gathers and stores potentially sensitive data, maintaining optimal Security posture has been a core concern since Hibob's initial stages. 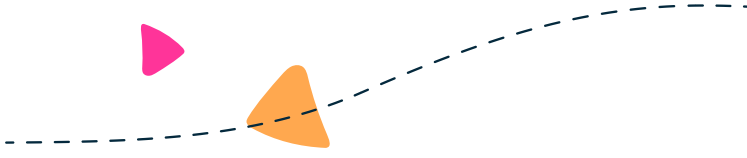
The Solution

After looking at several solutions that couldn't address their business requirements, Tamir Ronen (global CISO at Hibob) turned to Anecdotes. They were excited at the prospect of building a compliance program that could easily scale as their needs grew but what really sold them was the possibility of keeping their data within their own perimeter. According to Kimhi, "In the world of SaaS services, it's difficult to find a product that allows you to take advantage of its capabilities while still keeping the information in our internal environment and Anecdotes allows us to do exactly this."

Here is how this is possible: when using the data delegation capability, Anecdotes serves only as a processor and the customer remains in control of their data the whole time. Secrets (or tokens) are provided by Hibob in order to authorize Anecdotes' collection engine to read raw data. This is unprocessed data that comes from different sources across the organization, such as cloud environments and security, HR, and CI/CD tools, etc., from SaaS/multiple sources/integrations. Metadata is created by Anecdotes as part of the usage (gaps, owners, etc.) and is the glue that provides context and acts as a reference to the raw data itself. This means that data is always stored within Hibob's own perimeter.

The Results

With Anecdotes' proprietary data delegation capability, Hibob can use the Compliance OS processing engine to automate evidence collection, streamline project management, get a unified view of controls and more, while storing all data and secrets exclusively inside their own perimeter, to own and retain their data at all times.
