The Challenge

As a cybersecurity company, Axonius prioritizes GRC. They selected Anecdotes to help manage and continuously improve their GRC program. However, Anecdotes' direct integration with AuditSource eliminated these manual steps, streamlining our audits and significantly reducing the time to enable the team to focus on other priorities."

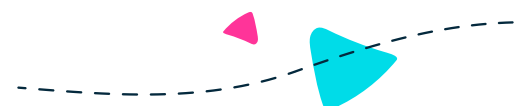

The Solution

Anecdotes and Schellman are long-time partners. To deliver the best combination of GRC technology and services, it only made sense to integrate the Anecdotes platform with Schellman's proprietary audit management tool, AuditSource. "Anecdotes has built a platform that is highly customizable and scalable, which allows Schellman and Anecdotes to collaborate on how we can create a better audit experience for our customers". said Jeff Schiess, Managing Director at Schellman.

The Anecdotes developer team coordinated with Schellman to build an integration that bridges the Anecdotes Compliance OS and AuditSource. Now, a simple toggle sends evidence marked "ready for audit" directly to AuditSource. Behind the scenes, this workflow includes an additional check for quality control in AuditSource before the auditor sees the information. This final check gives customers extra assurance that they are only sharing relevant data with the auditor.

This integration enabled faster audit prep and execution, allowing Axonius to leverage Anecdotes' customization capabilities to scope the evidence to meet Schellman's requirements, and Schellman's auditors accepted the automatically collected evidence. The integration significantly reduced the time and resources required for Axonius's audit process.

Anecdotes enables organizations to proactively identify and address potential risks, and the Axonius GRC team effectively utilized this functionality to prepare for their audit. This proactive approach allowed them to set clear expectations with the auditor, fostering trust and collaboration by acknowledging potential concerns and outlining their mitigation strategy. This mature posture impressed the auditors, including Kristen Wilbur, Principal at Schellman. "Axonius did a great job with Anecdotes' tools. They did the work and that is what made this so successful."

From Schellman's perspective, the evidence Axonius sent through the Anecdotes integration arrived exactly as they expected. "It looks no different from my end than when a manual user uploads this evidence. 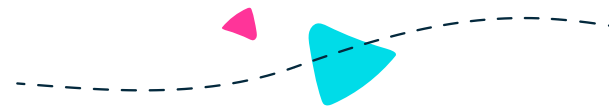


The Results
